Ladies & Gentlemen:

Yesterday and tomorrow are great opposites. What has been done cannot be undone because we cannot go back to the past. So we look forward to the future to see what can be done because we have to make our choices today to effect the changes we wish to make in the shaping of our destiny as a modern barangay in the Municipality of Pinamalayan.

Now, the Two million, forty six thousand three hundred ninety three pesos (Php 2,046,393.00) budget of Barangay Buli for CY 2018. The Sangguniang Barangay passed without delay and deduction, designed to effect necessary changes and development to bring us closer to our practical vision of being self-reliant and progressive modern barangay.

Policy Thrust for CY 2018

Our policy thrust for CY 2018 is our barangay economy, We desire to reduce unemployment by 20% and at the same time increase our local revenue by 20%. We concentrate our resources to the economy because this is the only way to become self-reliant. We want our marginalized resident in the rural areas to be the focus of our investments. the policy measures to support our CY 2018 budget are the following;

- 1. Make our tax collection more efficient.
- 2. Increase our local revenue by augmenting our fees for the use of barangay facilities.
- 3. Give priority to the delivery of quality basic services to all constituents.
- 4. Use of surplus or savings to priority development projects.

Estimated Income for CY 2018

Our estimated and realistic income for CY 2018 is more or less Php 2,046,393.00. Our share from internal revenue collection still is our number one source of income. We must be more aggressive in our next coming year by strengthening our local economy to make our tax and fees collection more efficient.

It is expected at the end of the decade, we will turn the tide in our revenue structure and increase the share of our local generated income to 80%. We shall pursue similar strategic policies on income generation in the coming year to attain our vision of self-reliant in five (5) years. All this cannot be achieve without your strong and firm support in the execution of our policies.

Income Allocation for CY 2018

Our income on the basis of our approved fiscal or budget policies gives premium to the delivery of quality basic which is allocated 55% as our biggest expenditures followed by our governance and legislative servicers of 20% for implementation of development priority projects. 10% SK Fund, 5 % of GAD, 5 % is our budgetary requirement for calamity fund and the balance is allocated for the maintenance and other operating expenses. This percentage allocation of our income once confirmed and approved shall be maintained for the next five (5) years emphasis, our commitment to be more responsive in basic services delivery.

As a public servant, I humbly stoop and down my head to all my constituents whom I have pledge to serve until the end of my term. I have to deliver those basic goods and services and development project to you as our stakeholders. If at the end of the day you do not find these services delivered, then you be the final judge on judgement day.

BARANGAY APPROPRIATION BILL NO. 2
